## **LEGAL REQUIREMENTS**

As a result of legislation in 2019 (A.776/S.1101), signed into law Jan. 24, 2019, amending Election Law Section 14-116 and 14-120, Limited Liability Companies and Professional Limited Liability Companies that make contributions to, or expenditures for, candidates or political committees now have a disclosure requirement with the New York State Board of Elections.

For Agents Advocacy Coalition to abide by our portion of this legislation, we ask that if you are a Limited Liability Company or a Professional Limited Liability Company making an Agents Advocacy Coalition donation, that you provide the following information (in addition to completing the reverse side of this form):
